## VHF Column

Status of VUAC. George, W9GIG and Kermit, W9XA, the Central Division's VUAC representative, have set up a reflector for VUAC activities. The reflector is designed to provide Central Division ARRL members with access and input on proposals at the VUAC level. If you are a Central Division League member interested in VHF contest rules, I suggest that you participate. W9XA will forward comments to the VUAC for further consideration. You can sign up for access to the reflector by contacting W9XA.

So far in the process, a majority position as to rover rule changes has been tentatively established, but that evidently can change, depending upon input from the VHF community via these Division level reflectors. The majority position as of 4-27-07 is to:

- Develop a new limited rover category for four band rover operation;
- Keep the regular rover category for all band rover operation;
- Also develop a new unlimited rover class, apparently designed to put the pack rover operations into, without specifically banning pack roving practices;
- Specifically allowing for APRS in rovers;
- Amending the family rule to allow multiple calls from the same rover to be used by family members.
- Allowing a non-op driver in rovers, as a safety issue.

No position has yet been established on non-rover changes, but that may be forthcoming from the VUAC at some point. If you want exact wording of the proposed rules, it is on the Kermit's reflector, along with very good commentary from several well-known central Division VHF contesters. See W9XA for access.

I do want to compliment W9GIG and W9XA for this layer of communication (and W9FZ for hosting the list). It certainly makes the process more transparent than last time, and provides for ARRL member comment and input at any earlier stage. Coupled with the VUAC survey that was previously done in November, 2006, no one should be surprised by whatever final proposals surface from the VUAC level. Kermit is hoping that consensus will develop among Central Division League members, so that he can report our reaction to the majority position that has been formulated by VUAC. That may cause a change in the proposals at the VUAC level. If you like or dislike the above proposals on rovers, please see W9XA!

extra \$125 for excess weight (\$100 for the golf case and \$25 for the regular suitcase). At the ORD security checkpoint the wheelie bag with all the radio equipment was completely swabbed. I asked the dude how many of the tests came up positive. His response was that only the first test was positive.

I arrived at MIA approx 2 am. In order to find the gate for the MIA-NAS leg I had to call AA, hah! The airport monitors were all off at that time. Luckily, I was able to get a little sleep by laying across three sets.

In 2007, I decided to leave on Weds afternoon and take a direct flight instead of leaving Weds night and using a connection through Miami. That worked out well since I was able to check into the hotel by 5pm Weds and finish setup by 4pm Thursday. Better yet I was able to take a nap before the contest in 2007.

### **Will I ever get set up (2006)?**

I purposely took an early Thursday morning flight to NAS in order to allow for more setup time. I arrived at the hotel at 10:30am. Unfortunately the fifth floor was being remodeled. So I asked for a fourth floor room over the flat portion of the roof. The clerk said I'd have to wait until 12:30 or 1pm. My luggage was checked into the hotel storage area.

The previous day I checked with the licensing clerk to insure that she'd be there on either Thu or Fri. So I used the down time to walk over and pay for my license for 2007-2010. Unfortunately, I started walking without a hat (my head is bald) or sunscreen. So I got some sun in the first few hours on the island.

Returning to the hotel around 1pm I was informed that there still was no room available yet. Eventually, I decided to haul the golf case (used primarily for antennas) to the roof. Around 2pm I began assembling antennas. Sometime after 3pm I finally got a room.

Most of Thursday was taken up with setup work etc.

### **Mr. Murphy – Where are thee?**

Invariably there are problems that occur. Hopefully they aren't show stoppers. The biggest issue was the SWR on 40m with the F12 antenna. I had set it up in the backyard at home and got a 1.7:1 SWR although here it was 3:1. When taking down the antenna on Sunday I realized why! There were two markings on the element length and I evidently incorrectly constructed the element spacing.

Another issue was that the SWR on the 80m dipole was infinite. In talking to Jerry KE9I he mentioned that was most likely a loose connection. I hadn't used the 80m dipole since

sweepstakes 2002 (or maybe 2001) so anything was possible with it by this time. It ended up being loose lug nuts on the balun. Once those were tighten, it worked great. I eventually used it on 40m sometimes in place of the F12. Post note: It really was a 40m dipole which for some stupid reason I thought it was an 80m dipole...doy! I've since decided to mark any antenna I make, hah!

While at Dayton (the previous weekend), Dennis K7BV/1 had mentioned that six meters was quite good. He also mentioned that The Bahamas are somewhat rare on 6m. So the Cushcraft 3 element 6m beam was tossed into the golf case in case there was some opening. Unfortunately, I had never tried out the FT-857d on 6m (or even 6m SSB). The 857d had some kind of intermittent issue on 6m. I had thought it was the microphone but the mic worked fine with the FT-817 (brought along for backup). The FT-817 ended up being the primary 6m radio for the duration of the trip.

### **Wow is this really 6 meters?**

Ended up making over 400 contacts on 6m. Even worked a station near Green Bay, WI. Keith, W9RM made it into the log too. I worked from OK to TX to FL up to Canada / Maine. It was amazing what 5 watts and a 3 element beam at 55'-65' can do when you have a DX callsign.

I tried to speak fairly quickly in order to maximize operating time and work people before the band shifted. Seems like some of the old-timers must not have been used to an HF style operation on VHF since some asked me to slow down, hah!

Besides the contest operating, I had the most fun with 6m on this trip. I just love the FT-817. It really can play when the stars align.

In 2007, the FT-857D was repaired for 6m operation so I was all set for lots of 6m QSOs. The 6m openings were not as plentiful and I ended up with only 47 QSOs on 6m. Although the opening did extend into Canada! In order to reduce some weight in my baggage I left the 6m beam at home. Instead, I used the 40m dipole on 6m which seemed to work aok.

### **Rules...What rules?**

Umm, well I guess I should have looked over the rules a little closer in case I had questions. I had no internet access from the room. Local places charged \$6/hr to use the internet.

I had to take 12 hrs off time during the contest. I'm used to the WAE rules which only allows for a maximum of three off times in 12 hrs. I believe each one has to be a minimum of a half hour. The WPX rules just stated to take 12 hours off. Umm, does that mean a 10-12 min break can count? Uh

Oh. A copy of the rules is always a good idea, hah!

It would have been great to run USA on 40m during the day like sweepstakes. They would count for 4 points instead of the 2 or 3 pointers I could get on 20-10m. It was a great concept from my viewpoint but USA stations don't want to work one pointers (other USA stations) on 40m when they can work 2 or 3 pointers on 20-10m, hah!

### Let the contest begin

I had hoped to take a 1-1/2 nap in the mid to late afternoon on Friday before the contest started. I just wasn't tired enough. In addition, most of the afternoon was spent having fun on 6m. In the back of my head I wondered whether this was going to be a strategic downfall.

Started out on 40m due to the higher QSO point versus 20m. It was rough going with noise and a higher than planned SWR. At 01z I switched to 20m. Wow! The band is hopping! Made lots of QSOs on 20m and made up for some lost ground. Eventually I returned to 40m to hear the noise had quieted down. At 07z 20m was still going strong. I hated to take a rest at that time but I knew I wouldn't get too far in the contest if I didn't get some rest.

Saturday was a memorable day as the rates were keeping my occupied. At 22z Saturday, 15m was open to EU and JA at the same time. I thought we were near the bottom of the solar cycle? Late in the day on Saturday and into Sunday zulu time I had a three hour run on 20m, whew! Jerry KE9I called right around the beginning of the run so I'm sure he has some insight from the other end. It was great to work him from The Bahamas.

On Sunday morning I planned to place a breakfast order and have it delivered to the room so that I could keep operating. I ate a little later than usual so I ordered the steak and eggs to try something different. It was actually pretty good too! Also found out that Clif bars are good to eat during the contest <http://www.clifbar.com/>

As to be expected Sunday was slower rate wise than Saturday. My room looked out into the Atlantic and I was able to see the cruise ships and boats come and go. I'm a gym rat at home so with the rates being slower, I headed out for a jog. In addition, I was still searching for an artist to draw a painting for my QSL cards.

Also as usual for Sunday is bad packet spots. All of a sudden I started to work a fair amount of dupes. One even thought I was C6AQN...So I figured that out and sent my call three times in a row in order to get the pileup straighten out.

I thought someone was pulling my leg when I copied

UA3LID (short for U-A-LID). It ended up being a legit QSO based on the flow of the contact. I hated to give out the number 666 (sign of the beast) or 911. It's silly I know but there is some psychology to it, isn't there?

Some memorable mults are China, Korea, Kuwait, Australia, Norfolk Is, Hong Kong, and Palmyra.

On Sunday, the A/C started to sound like an old WW2 bomber plane. I figured by the time maintenance came to check it out and actually fix it I would have been gone. So I decided to just deal with it. In 2007, there was constant 10-20 mph winds. I was located in a corner room with windows on two walls. So I never used the A/C.

I took a quick look at 6m during a slower time on Sunday to hand out some QSOs.

If I took my score for 2006 and placed it in the 2005 top scores it would have placed 9th in the Word for SOAB-LP category. So we'll see how the other folks did this year. (I ended up placing 7th in the world for SOAB-LP in 2006.)

Funny thing about the WPX is that the top scores for SOAB-LP are mixed in with the SOAB-LP (Triband/single element). Kind of strange that CQ makes a separate category for them and then decides to group them back together for a top score listing!

### Will I ever get back?

My XYL had mentioned how hot the Nassau airport is. For some reason I did not remember that from our previous trips. Well she was definitely correct. It was blazing hot in the terminal, ouch! Initially the flight was scheduled to leave on time. We lined up at the gate only to later be told that ORD had weather issues. I was able to be first in line to board, which was advantageous in placing the carry-on wheelie bag with the radios.

We eventually boarded the plan although I was a little distressed to learn that I'd have to check the wheelie bag at the plane door. I asked the stewardess whether I could place the bag in the onboard compartment. She agreed but the Bahamian baggage loader made a big deal out of me trying to take my carry-on inside the plane when others had to check theirs. It seemed the stewardess didn't have (or want to use) any authority over the baggage handlers.

Once everyone was finally on board the plane, I overheard the pilot asking a lady about what exactly she had said about drinking. Well it turns out that the pilots had to get cleared from flight operations before we could leave. The total delay

at NAS was 1-1/2 hours.

Fortunately in 2006 my baggage was not weighed at the Nassau airport. Unfortunately in 2007, they were weighed! I knew I was in trouble when I saw the large scale that was perfectly visible upon entry into the terminal. Between 2006 and 2007, I paid a total of \$250 in overweight baggage charges. So the plan for the future is to find some storage facility to hold the antennas and coax as they are the heaviest of the baggage.

In 2007, there were no flight delays to speak of so that was enjoyable. I purchased a Pelican case that was carry on size. Although due to the small size of the aircraft the case got checked at the airplane ramp. The vibrations from the airplane trip loosened the CW/SSB filters in the radio and a screw on the top of the radio!

### **What's Next?**

Next year I might have to shift things around a little. I'll probably have some travel to Texas and Germany that will shift my contest plans around. I definitely enjoy the experience. The people of The Bahamas are very friendly and a joy to talk to. At some point I'll progress to getting into the big league of doing the CQ WW CW from C6A. I'd also like to do a VHF contest from there also.

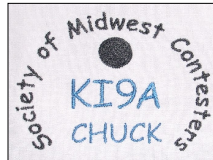
